New CPA members


In 2024, the Governments of Aguascalientes and Guanajuato became the newest members of the Carbon Pricing in the Americas platform.

Members Call - March 5th

CPA TRAINING

CPA'S Carbon Pricing and Article 6 Workshop and REdiCAP, Santiago de Chile



From July 22 to 26, 2024, the CPA, in collaboration with the UNFCCC RCC Latin America and ECLAC, hosted a five-day training on carbon pricing and Article 6.

The **Knowledge-Sharing and Hands-on Training** gathered CPA members, observers, and partners to explore various carbon pricing instruments, such as carbon taxes, with a special focus on the implementation of Emissions Trading Systems (ETS).

The event also featured **REdiCAP**, fostering regional dialogue on carbon pricing and sharing insights from the UNFCCC CiACA initiative. Additionally, it aimed to demystify Article 6 of the Paris Agreement, addressing its opportunities, challenges, and participation requirements.
